Local kids were playing soccer when the ball landed in their neighbour's yard—again! The older woman refused to return the ball. Tired of hearing his kids complain, a father pounded on his surly neighbour's door with a bat in hand. The frightened woman returned the ball and then called the police.

What should happen next?

We've been enculturated to believe that bad behaviour must be punished. Restorative Justice is not our first thought. But Restorative Justice is only a nice idea unless you and I embody it in our everyday lives. What if we got curious instead of jumping to punishment when we were in conflict or heard about a crime? We could ask, "What's happening in this person's life and how did their world shape them to believe their actions are acceptable?"

I see this generous curiosity among our volunteers and staff who come alongside people in conflict, including folks in prison and people who have caused sexual harm.

As CJI volunteers participate in Restorative Justice, they listen to multiple viewpoints, value every community member, and invite people to meaningful accountability. These skills become a way of being at home, work, school and in society.

We collaborate with volunteers so more folks are transformed by experiencing Restorative Justice. Slowly, but surely we are shifting the culture. Waterloo Region is becoming a restorative Region as we reach a critical mass of citizens, living by these practices and embodying a restorative world view.

Curious about the outcome of the neighbours in conflict? The local police referred them to CJI for mediation. Their tension dissolved as they truly listened to each other. The woman expressed her frustration over the ball breaking a sculpture made by her recently deceased husband. The remorseful father apologized for his threatening behaviour. Restorative Justice empowered these neighbours to transcend their conflict and embrace peaceful coexistence.

Imagine a community where everyone, everywhere, responds with Restorative Justice every day.

I invite you to join us on this journey and to be curious, kind, and committed to restoring relationships.

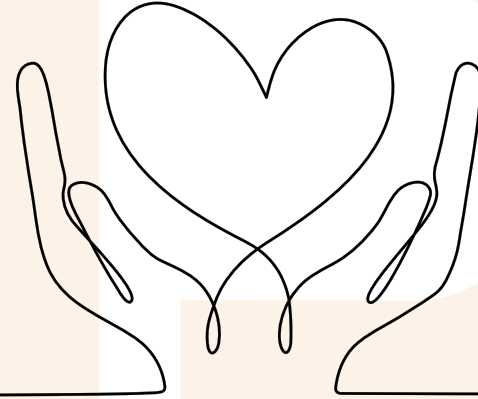
VISION

IN 2023/2024...

185 CJI volunteers gave 11,856 hours* embodying restorative justice with our community

2,356 people learned restorative justice skills through CJI's training and learning programs

9,584 people resolved conflict, learned new skills, and heard about the power of restorative justice through our programs, workshops and communications

*this equals \$320,000 of donated time, which is 19% of our budget.

Owner Meets Men Who Vandalized Her Business

Tami felt like a gut punch when customers told her the mural on the side of her business had been graffitied. A local artist had created the mural to pay homage to their small community.

Tami wondered why. Was it random? Did someone have a problem with the community or with her?

The two men who graffitied the mural were identified through nearby security cameras and were arrested. The courts recommended Restorative Justice to the men and Tami was eager to take part.

During the mediation, the men listened, explained, and accepted responsibility for

their actions. They also made amends by repairing and sealing the mural so that it could not be damaged again.

"I couldn't have asked for more. I had an idea in my head of what I wanted the outcome [of the mediation] to be, and they offered up the solution that was exactly what I wanted," said Tami.

Tami learned that one of the men was an artist. She offered him a spot on the wall to create a design to "use his talents in a positive way." She adds, "Restorative Justice gave me the answers and resolution that I never would have gotten had they gone through traditional fines or jail time."

THIS YEAR, THROUGH CJI...

89 people experiencing neighbourhood and community conflicts were provided with restorative processes

112 people dialogued after a criminal incident with support from CJI mediators

31 dialogues were facilitated in situations of identity-based harm to build connection and understanding across differences

8 people were matched with affordable housing arrangements through our Home Share program

THIS YEAR, THROUGH CJL...

481 coworkers in schools, businesses and organizations used a restorative process to manage conflict



108 teens and their caregivers and 112 caregivers and their impacted children were assisted in managing conflict



49 caregivers, children and their supports, involved with the child welfare system, participated in Child Protection Mediation, Family Group Decision Making, and Transitional Planning Conferences to navigate conflict and make decisions



1304 older adults were provided with social connections to ease the burden of social isolation

CJL's Elder Mediation Services collaborated with Kind Minds Family Wellness and several other community agencies to engage low-income, older adults at risk of isolation, conflict and abuse. In recreation groups, participants built relationships, learned about resources, and strengthened their conflict resolution skills.



Gwen (left) joined a weekly craft group when she moved to a Cambridge geared-to-income complex. "It's a friendly group. The girls are a laugh!" Gwen liked meeting new people, the crafts and a Waterloo Region Police presentation warning older adults about scams.

Supporting people impacted by sexual harm and experiencing prison.

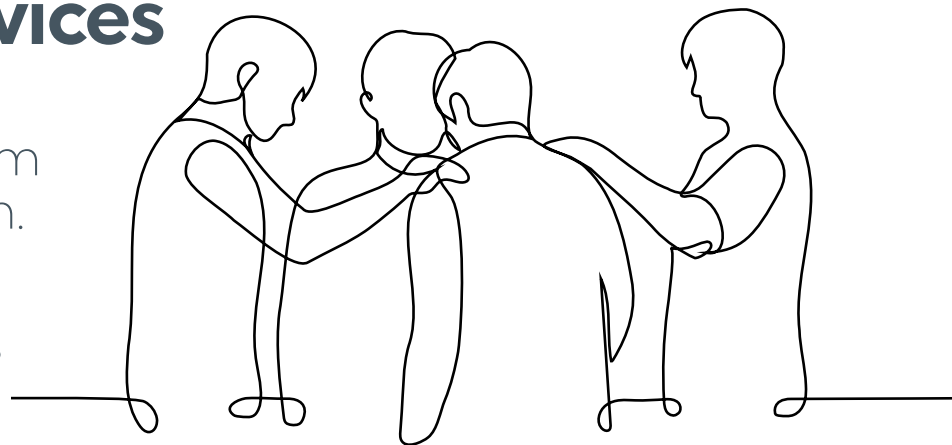
THIS YEAR, THROUGH CJJ'S REVIVE PROGRAM...

36 survivors of sexual harm were supported in their healing journey

26 family members, partners, and others impacted by sexual harm were provided space to share their experiences

39 people who offended sexually were assisted to address their offending patterns

11 facilitated dialogues brought people together to discuss impacts and needs after sexual harm



AND THROUGH OUR STRIDE PROGRAM...

92 Stride nights gathered 135 people in prison and community volunteers for recreation and relationship

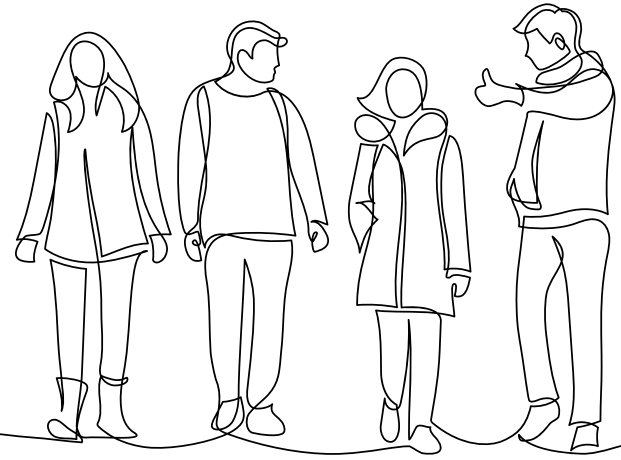
10 women or gender-diverse people were supported by a Circle of caring volunteers to return to the Waterloo Region community

Communities are transformed when individuals adopt more restorative ways of thinking and acting in their families, neighbourhoods, schools, and workplaces.



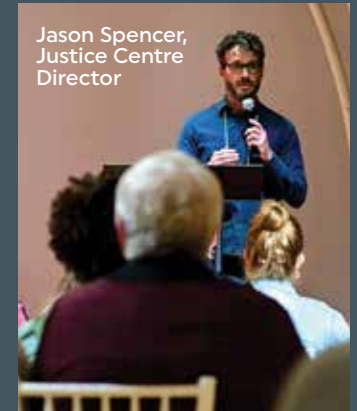
CJI TRAINING TRANSFORMS

In her Wilfrid Laurier University law and society classes, Felicia C. heard about Restorative Justice as theoretical and "nice to have". Then, a professor said CJI puts Restorative Justice into practice. Intrigued, Felicia signed up for CJI's Elder Mediation Co-Mentorship Training.

Felicia found the training "inclusive and welcoming". In one activity, participants chose an object to spark vulnerable sharing of personal stories. They related authentically as they listened deeply and discovered common ground. "True listening is more than waiting to say how you can help," said Felicia. After the training, friends and family noticed Felicia connected with them more deeply.

Felicia observes that the traditional justice system doesn't value everyone equally. "We support everyone except 'those people.' But, Restorative Justice is available to all."

In March 2024, 150 people gathered to launch CJI's Community Justice Centre. The Centre is a catalyst to address the roots of deeply entrenched social challenges in Waterloo Region. To begin with, the focus is on: identity-based harm, homelessness, and youth. CJI's Justice Navigators are collaborating with leaders stewarding the "headwaters" of our community to effect upstream change.
